

Be warned: This is not really a book and there are no descriptions of combat. Instead it is a very thin, 31 page (large type) book of leadership points. I have purchased and read many great books from . This is not one of them. The two authors are highly decorated SEAL veterans of the Iraq war. The points they make are certainly relevant, but none are of the "that's something I had never thought about" type. I was shocked when I received this as I had thought it would be a book with some interesting stories and post-op analysis. Unfortunately, I can not recommend it. should have done a better job of explaining that this was not a book. I was going to return it, but because I only paid \$7.00, I didn't bother.

Authors Jocko Willink and Leif Babin wrote the original book having gained real life experience working together in the US SEALs. After leaving the SEALs they "founded the leadership

consultancy firm Echelon Front to bring the leadership lessons of the SEALs to the private sector". In this Instaread summary (think DETAILED review) which is a little longer than usual, the reader is presented with 12 Key Takeaways. Here are three to whet your appetite:>> #1 - "Leaders must demonstrate extreme ownership with everything they have responsibility over.">> #8 - "Plans and principles should be simple to ensure that they are understandable by everyone involved and easy to communicate. A plan that is unnecessarily complicated is more likely to fail.">> #9 - "A thoroughly detailed plan that every team member understands is vital to mission success. A good plan accounts for all likely risks and allows for flexibility."As leaders it is easy to want to pass the buck / blame onto someone else but it is important for a leader to take responsibility. Babin takes responsibility for the death of Marc Lee, a SEAL who died under his command. How is ego an obstacle to good leadership? We all know how important cover is in military maneuvers but how about in the business world?A great book for leaders with much practical advice.
